Minutes March 21, 2022:

Mr. Fingar made a motion, seconded by Mr. Calvin to approve the draft minutes from March 21, 2022 as presented. Carried.

Committee Appointments New Board Members:

The Committee discussed potential committee appointments for the new members and existing members who expressed a need to change due to scheduling conflicts. Mr. Fingar asked Ms. Gay if she would consider becoming CEDC's Treasurer. Mr. Fingar made a motion, seconded by Mr. Calvin to suggest Ms. Gay for the Treasurer's position to the Full Board. Carried.

Other Business:

Mr. Tucker noted that the review of the CEDC committee charters and the IDA committee charters was in process. He suggested that the 2 corporations together be reviewed by Mr. Howard's firm for a set fee not to exceed \$5,000. Ms. Sterling noted the City of Hudson IDA had conducted workshops. Mr. Tucker reviewed the process the HIDA had gone through in order to incentivize certain types of projects. He noted

their counsel was unsure if the IDA could actually adopt some of the ideas. He suggested the County IDA observe the process and see what could be taken from it.

Candidate Interviews:

Ms. Sterling called for a motion to enter Executive Session. Mr. Fingar made the motion, seconded by Ms. Gay to enter Executive Session under Article 7 Section 105 (f) of the Public Officers Law for the purpose of discussing the medical, financial, credit or employment history of a particular person or corporation, or matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or corporation. Carried. Executive Session was entered at 8:58 am.

Mr. Calvin made a motion seconded by Mr. Fingar to exit Executive Session. Carried. Executive Session was exited at 9:16am.

Ms. Sterling asked for a motion to recommend the candidate to the full board. Ms. Gay made a motion, seconded by Mr. Calvin to recommend Mr. Sawyer as a candidate to the Full Board at the next meeting. Carried.

Mr. Fingar made the motion, seconded by Ms. Gay to enter Executive Session under Article 7 Section 105 (f) of the Public Officers Law for the purpose of discussing the medical, financial, credit or employment history of a particular person or corporation, or matters leading to the appointment, employment, promotion, demotion, discipline, suspension, dismissal or removal of a particular person or corporation. Carried. Executive Session was entered at 9:18 am.

Mr. Calvin made a motion seconded by Mr. Fingar to exit Executive Session. Carried. Executive Session was exited at 9:33am.

Having no further business and no public comments, the committee meeting was adjourned at 9:33 a.m. on a motion by Ms. Gay, seconded by Mr. Fingar. Carried.
