Columbia Economic Dev Corp: Good morning. My name is Carmine Pierro. I'm chairman of Columbia County Industrial Development Agency in connection with the matter which is subject in the public hearing. Today we are holding public hearing to allow citizens to make a statement to the record relating to the involvement of the agency.

The following matter pursuit to a closing. On May 12,017, the agency entered in a release agreement, dated as of May 1, st 2,017, and a payment in lieu of tax agreement, dated, as of May 1, st 2,017 each. By and between the agency and 41 Cross Street Hospitality, Llc. The prior owners of the company, in connection with the project, consisting of the following, the acquisition of an interest in approximately point 5 0 acre parcel of land located at 39, 41, and 43, 51 Cross Street.in the city of Hudson, Columbia County, New York, together with the existing land located thereon, containing approximately 40,800 square feet of space. The renovation, reconstruction, and upgrading of the existing facility and related improvements located on the land, the existing facility and improvement here and collectively referred to as the facility and 3. the acquisition and installation therein of certain machinery and equipment, the land, the facility, any equipment here and collectively referred to as the project facility, all of the foregoing to be owned by the prior company and operated as a boutique hotel facility, and other directly and indirectly related, uses the granting of certain financial assistance within the meaning of section 8, 54, 14, of the act which respectively to the foregoing, including potential exemptions from certain sales, and use taxes and real property taxes and real property transfer taxes and mortgage recording taxes and the lease of the project. A New York State Limited Liability Company, submitted an application to the agency, a copy of which application is on file at the office of the agency, which application requested that the agency considered a request by the new company for approval, by the agency of certain assignment and assumption relating to the project said assignment request, consisting of the approval of the agency of the assignment by the Prior Company to New York of the lease agreement., the payment in lieu of taxes and certain other documents entered into by the prior company in connection with the closing. payment blue with taxes entered into by the prior company in connection with the closing collectively, the basic documents, the assumption by the New York Company, of the basic documents and to provide the new company with sales tax exemption.

I intend to provide general information of the agency's general authority and public purpose to provide assistance to the assignment request. I will then open the comment period to receive comments from all present who wish to comment on either, assign a request for the additional facility. On August 6, 2,024, the resolution authorized to sign an assumption and public hearing in connection with assignment and assumption authorize the agency to conduct the public hearing with respect to the assignment request. Lastly, copies of the public Hearing notice were posted on August 21, st 2,024 on a public bullet located at City Hall, located at 5 20 Warn Street, in the city of Hudson and one Hudson City Center suite, 301 in the city of Hudson, Columbia County, New York, were posted on August 21, 2,024 on the agency's website, a copy of the certified resolution authorizing assignment and assumption and public hearing in connection with the assignment and assumption, was mailed to the affected taxing jurisdictions on August 21, 2,024, copies of notice of the public hearing are available on the website of the agency.
